

**ALPHA MEDIA'S CONTEST-SPECIFIC RULES FOR THE
May Vacay Giveaway CONTEST**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

These contest-specific rules should be read in conjunction with Alpha Media's General Contest Rules, which are applicable to all contests conducted by Alpha Media Holdings LLC and/or its subsidiaries (including licensee subsidiaries).

1. Promotional Period: The May Vacay Giveaway contest (the "Promotion") begins on or around Wednesday, May 15th 2019 at/around the time of 6:00am CST and ends at/around the time of 6:00pm CST on or about Friday, May 31st 2019 (the "Promotional Period").

2. Entry Deadline: The deadline to submit entries is Friday, May 31st 2019 around the time of 6:pm CST.

3. Eligibility Restrictions: The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 21 years of age or older at the time of entry. Employees of Star 105.5 - WZSR (the "Station"), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcast stations in the Station's listening area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY, RI and FL, as applicable, and where prohibited.

Listeners are eligible to win an Alpha Media contest valued at \$600.00 or more only once every six months.

Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from any individual who does not meet the eligibility requirements, and will also delete any entry as required by law.

4. Entry Method: To participate in the Promotion, you may enter via the following method(s).

VIA FACEBOOK – Visit the Station Facebook page at <https://www.facebook.com/star1055fm/> . Click on the Promotion entry form and enter the requested information, which may include your

first and last name, to post a comment on that status, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth. Facebook entries will be deemed made by the authorized account holder of the Facebook account used to submit the entry at the time of entry. The authorized account holder is the natural person who is assigned to the Facebook account by Facebook. Multiple entrants are not permitted to share the same Facebook account. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's computer is the official time-keeping device for the Promotion.

This Promotion is in no way sponsored, endorsed or administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the Promotion's administration, prizes or promotion. You are providing entry information to the Station and not to Facebook.

VIA TELEPHONE – To qualify for a chance to win the grand prize it's a cue to call at 1-800-861-1055 between the hours of 6:00am CST – 6:pm CST Monday through Friday. At the time of their call entrants must provide all requested information, including their first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's telephone system is the official time keeping device for the Promotion. Only one entry per day per household. Only one entry per duration of campaign.

5. Prizes: (1) one three night trip for two adults to Barcelo Maya Grand Resort in Riviera Maya, Mexico valid through 12/10/2019. The trip includes three night accommodations, roundtrip nonstop air from Chicago O'Hare, ground transfers to/from the airport and hotel, all meals and drinks and the assistance of an Apple Representative. Winners must be at least 21 years old to redeem the prize. Three-night trip to Barcelo Maya Grand Resort in Riviera Maya, Mexico for two adults departing from ORD, Chicago O'Hare. Trips include three-night accommodations, round-trip charter air, transfers to/from resort, non-motorized watersports, all food/drinks at the resort and the assistance of an Apple Representative. Trips are valid for travel through December 10, 2019. Taxes, insurance, any applicable baggage fees, and additional expenses (such as optional excursions, spa treatments, phone calls and souvenirs) are the sole responsibility of the winner. Winners will be provided them a copy of the attached Reservation Request Form. They should be instructed to read pages 1 and 3 carefully. Winner must be at least 21 years old or traveling with a legal guardian. Employees of participating companies and its properties, sponsors, vendors and their immediate families are not eligible to win.

6. Odds of Winning: The odds of winning depend upon the number of entries received.

7. Winner Selection and Notification:

Decisions of Station management with respect to the Promotion are final.

All entrants and previous on-air qualifiers will be invited to a grand prize event located at Benton Street Tap on the Woodstock Square in Woodstock, IL on Saturday, June 1st between the hours of 3:00pm CST and 5:00pm CST. One winner will be selected at random at approximately 4:50pm CST. All entrants must be present to win at the time of winning. Entrants must check in at the Star 105.5 – WZSR table before 3:30pm CST to be entered in to the contest. All decisions are final.

All winners will be notified on the next working business day via telephone or via email with winning descriptions from a Promotions Department team member.

8. Conditions:

a. Payments of all federal, state and local taxes are solely the responsibility of the winner(s). Winner(s) will be required to complete and submit an IRS Form W-9 or the equivalent including a winner's full Social Security Number for receipt of any prize valued at \$600 or more or for any prizes awarded by the station conducting the Promotion (in combination with any prizes won in Promotions run by any other Alpha radio station) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in disqualification and forfeiture of the prize.

b. ii. acknowledge that Alpha reserves the right, in its sole discretion, not to use the Materials at all; and

iii. represent and warrant that: you are at least as old as the age of majority in your state; you have the full legal right, power and authority to grant to Alpha the license provided for herein; you own or control the complete exhibition and other rights to the Materials you submitted for the purposes contemplated in this license; you are either the parent (or legal guardian) of any minor featured in the Materials or have received the express consent of the parent (or legal guardian) for any such minor to appear in the Materials and to enter the minor's likeness in the Materials in the contest; and neither the Materials nor the exercise of the rights granted herein shall infringe upon or violate the right of privacy or right of publicity of, or constitute a libel or slander against, or violate any common law or any other right of, any person or entity.

d. Prior to awarding any prize or prize certificate, and depending on the nature of the prize and eligibility requirements of the Promotion, Alpha in its sole discretion may require verification of Promotion winner's or winners' identification by a showing of valid government-issued photo identification.

e. To the fullest extent permitted by law, by participating and/or accepting a prize, entrants, winner(s) and guests (if applicable) agree to release and hold harmless the station conducting the Promotion, its sponsor(s) and promotional partner(s), its advertising and promotion agencies, any social media platform utilized in the conduct of the Promotion (including but not limited to Facebook, Inc.) and each of their respective parent, subsidiary and affiliated entities, and the officers, shareholders, directors, employees, agents, representatives, successors, and assigns of each of them (collectively, the "Released Parties") against any and all claims or liability arising directly or indirectly from the prize or participation in the Promotion. Alpha may also require eligible Promotion winner(s) and their guests or travel companions, if any (as well as each of their parent(s) or legal guardian(s), if winner(s), guest(s) or travel companion(s) are under the age of majority in their state of residence), to sign a liability release confirming such consent. f. capable of completion as planned or if any fraud, technical failures or any factor beyond the station's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion as determined by the station in its sole discretion. Any attempt by an entrant or any person to deliberately damage any station website, Facebook Page, and/or any other social networking site used in the Promotion or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Alpha reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The station's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the station conducting the Promotion, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the station reserves the right, but not the obligation, to modify, terminate, suspend or cancel the Promotion and shall not be required to award a substitute prize.

The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals, or any other difficulties that may prevent an individual from sending or receiving a text message; or (iii) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, incorrect, or late entries. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of god, acts of war, natural disasters, weather, acts of terrorism or other factors beyond Alpha's control.
